

It is further subdivided into three Census Divisions: South Atlantic (Delaware, D.C., Florida, Georgia, Maryland, North Carolina, South Carolina, Virginia, and West Virginia); East South Central (Alabama, Kentucky, Mississippi, and Tennessee); and West South Central (Arkansas, Louisiana, Oklahoma, and Texas).
